A report examining local health planning and needs assessments in relation to dying people and finds that 34 per cent of health and wellbeing boards do not take into account end of life care needs. The report calls for greater collaboration in order to better cater for local palliative and terminal care needs.

Books Beyond Words has gone mobile and created a new app, which holds over 400 short picture stories and 1800+ pictures from across their entire back catalogue. This includes several picture books relevant to cancer (incl screening), loss, bereavement, death and dying, such as: When Dad Died, When Mum Died, When Somebody Dies, Getting On With Cancer, Looking After Your Breasts, Am I Going To Die?

The app has been designed to work on your tablet or smartphone, and is powered by both iOS and Android. The app is available to download for free with limited content from the App Store and Google Play, and for £29.99 per year you can unlock the full version with access to our entire library of pictures. They also offer an expanded organisation subscription, complete with a bookshelf feature, for small and larger organisations, saving up to 50% on each user. ## CARE QUALITY COMMISSION

### 'A different ending': addressing inequalities in end of life care

This review of end of life care found that people from certain groups in society, including people with learning disabilities, sometimes experience poorer quality care because providers do not always understand or fully consider their needs. In light of this, the report argues that some commissioners and providers might not be fulfilling their duties under the Equality Act 2010 as all public bodies have a legal duty to consider the needs of a range of equality groups when carrying out their day-to-day work. The review identified examples of good practice, but found that action is needed to make sure everyone has the same access to high quality, personalised care at the end of their lives, regardless of their diagnosis, age, ethnic background, sexual orientation, gender identity, disability or social circumstances.
